


## NAGALAND PROJECT March 2025 - April 2030

ELEMENT (Enhancing Landscape and Ecosystem Management), Nagaland Project, is a five-year project financed by the World Bank-International Bank for Reconstruction and Development (IBRD). The project aims to promote sustainable landscape management in Nagaland. With a total budget of INR ₹ 718.28 Crores, the project will be implemented over 5 years in 225 villages across 16 districts by the Society for Climate Resilient Agriculture in Nagaland (SoCRAN) under Agriculture Production Commissioner Cell (APC Cell).

The State's forests comprise about 74% of the total area, of which 97% is owned by communities. About 70% of the population of Nagaland relies on agriculture and forests for their living.

Faced with the threats of global warming and climate change, effective conservation of forests and ecosystem services such as soil, water, plants, and animals, air and biodiversity need to be prioritised, which is particularly crucial in the State.

The varieties of spices, condiments, and aromatic herbs in Nagaland are promising inputs for private sector investments and jobs. To realize this potential, the State needs creative solutions for facilitating and organizing supply chains linked to potential markets, skilled labor, and processing technology.



The Project will encompass all aspects of biodiversity, food, water, air, shelter, livelihood, economic growth, and human well-being, including resilience to climate change.

By adopting a holistic landscape approach, the project aims to empower forest-dependent farming communities to make scientifically informed decisions, restore forests, preserve biodiversity, and promote climate-resilient agriculture and livelihood-support activities.

Improve landscape management and increase benefits for targeted forest dependent communities in Nagaland.

This will ensure fairness and justice by giving individuals a voice, promote transparency through open and accountable processes, and resolve issues efficiently with a timely and structured approach.




The concept of the Project is to adopt and conserve individual, clan, and community forests, support green growth and sustainable livelihood enhancement, and have provision for ecosystem services.

The proposed Project activities are community livelihood, integrated nutrient management, pest and disease management, moisture conservation and irrigation, mechanization and marketing infrastructure and services, afforestation and natural resource regeneration, spring rejuvenation and catchment protection, capacity building of local communities, and preparing landscape management plans.
