## **Abstract of Minutes of the Procurement cum Purchase Committee (PPC)**

### **Meeting held for “Conducting Baseline Study for ELEMENT Nagaland”.**

1. The committee examined the proposals received from the following firms who had responded to the RFP No. IN-SOCRAN-503478-2025-CS-QCBS, dated 26th August 2025; Amendment to the RFP issued vide No. APC/ELEMENT-WB/BASELINE/33/2023/713, dated 11th September 2025 & Corrigendum to the RFP issued vide No. APC/ELEMENT-WB/BASELINE/33/2023/714, dated 11th September 2025.

2. The technical evaluation is done following the basic criteria as mentioned in Clause 21.1 of the ITC of the RFP: "The Client's evaluation committee shall evaluate the Technical Proposals on the basis of their responsiveness to the Terms of Reference and the RFP, applying the evaluation criteria, sub-criteria, and point system specified in the Data Sheet. Each responsive Proposal will be given a technical score. A Proposal shall be rejected at this stage if it does not respond to important aspects of the RFP or if it fails to achieve the minimum technical score indicated in the Data Sheet".

Further, as per Clause 21.1 of the Data Sheet of the RFP, "Consultants technical proposal shall be evaluated in two parts. Part A (as mentioned below) shall be the mandatory criteria that the consultants must meet. Technical Proposals of Consultants who do not meet the criteria in Part A, shall not be further evaluated and the proposal shall be rejected. Technical Proposal of Consultants, who meet the criteria in Part A, shall be evaluated further using the scoring scheme contained in Part B below."

3. While evaluating the technical proposals, the Committee observed the following:

- (i) **M/s Excel Green Enviro Care (Excel)**; (ii) **M/s Himalayan Institute for Environment, Ecology & Development (HIFEED) (Lead), In Joint Venture with: M/s Greenhexa Techserve Pvt. Ltd. (HIFEED)**; (iii) **M/s Society for Resource Planning, Development and Research (SRPDR)**; (iv) **M/s Sigma Research and Consulting Pvt. Ltd. (Sigma)**; and (v) **M/s The Energy and Resources Institute (TERI)** have not complied "During last five years as on proposal submission deadline, firm shall have successfully completed Baseline Study/ Evaluation/ Socio-economic Survey in minimum three contracts with value no less than INR 2 Million each". Hence, the consultants could not meet the mandatory criteria in Part A and are **ineligible for further evaluation**.
- **M/s Thinkthrough Consulting Private Limited (TC)** has not provided "Audited Financial Statement for F. Y. 2022-23, 2023-24, 2024-25". Hence, the consultant could not meet the mandatory criteria in Part A and is **ineligible for further evaluation**.

4. After deliberations and having considered their technical proposal, experience and past performance, approach & methodology, qualification and experience of proposed key staff, etc. vis-à-vis the requirement stipulated in the RFP document, following technical points are awarded to the firms. The Detailed Technical Evaluation Report is attached herewith.
