
The following points were discussed and decided upon:

- Opening of financial proposal:** The financial proposal was opened through the nagalandtenders.gov.in portal in accordance with the Procurement procedures based on the Request for Proposal (RFP).
- Decryption of the Digital Signature Certificate (DSC):** As per protocol a minimum of 2 out of the 3 designated DSCs were required to open and access the RFP. The documents were opened using the DSCs of the Procurement Specialist and the Finance Specialist.
- Financial bid:** The financial proposal submitted by the eligible bidders were opened in the presence of the Evaluation Committee. The quoted amount by the proposal was read aloud in presence of the committee. The total prices quoted are as mentioned below:
