




**Note:**

- \* The firm, M/s APT & Co. LLP has already been selected for award of contract for the assignment relating to "Hiring of Chartered Accountant Agency for Statutory Audit of ELEMENT, Nagaland". The Financial Management Technical Support (Accounting) Consultant (FMTSC) will provide the necessary operational and technical support to strengthen the project accounts staffs with adequate training to ensure that all financial management aspects (including necessary financial and accounting aspects) of the project are satisfactorily handled. Moreover, the FMTSC would, work in close collaboration with the project accounts staffs. Whereas, the Consultant engaged for the Statutory Audit of ELEMENT will verify/ audit the tasks of the FMTSC independently.

According to the ITC Clause 3. b. (ii) of the RFP Document relating to 'Conflict among consulting assignments: a Consultant (including its Experts and Sub-consultants) or any of its Affiliates shall not be hired for any assignment that, by its nature, may be in conflict with another assignment of the Consultant for the same or for another Client'. Hence, in terms of the above, M/s APT & Co. LLP shall not be eligible for the assignment relating to 'Financial Management Technical Support (Accounting) Consultancy' or any other assignment under ELEMENT, as there will be direct conflict of interest with the assignment relating to "Hiring of Chartered Accountant agency for Statutory Audit of ELEMENT, Nagaland". Therefore, M/s APT & Co. LLP has not been ranked and their Financial Proposal will not be opened.
